The Dale County Commission convened in regular session Monday, August 22, 2011. The following members were present: Judge Eunice Hagler, Chairperson; District One Commissioner Douglas M. ### <u>APPROVED – ONE-TIME RETIREMENT INCENTIVE</u>

After some discussion, Mr. McKinnon made a motion to approve a one-time retirement incentive in an amount of up to \$10,000 for qualified employees with 25 years or more employment with the county and 25 years participation in RSA, and who agree to apply for retirement before August 31, 2011, and who agree to continue to participate in the Local Government Health Insurance Plan as a Retiree for 3 years or to age 65, whichever is longer. A memo will be sent to all county employees explaining the details of the plan. Mr. Gary seconded the motion. After recommendation, Mr. McKinnon amended his motion to include a retirement effective date of October 1, 2011. Mr. Gary seconded the amended motion. All voted aye. Motion carried.
