Judge Hagler called the meeting to order at 6:00 p.m. Commissioner McKinnon opened with the Pledge to Allegiance. Commissioner Williamson followed with prayer.

RESOLUTION – RECLASSIFICATION OF COUNTY ROAD 63 - #2012-07-09-01

Mr. Gary made a motion to approve the Resolution to reclassify County Road 63 from Al Hwy 134 northerly to US Hwy 231 as a major collector. Mr. Williamson seconded the motion. All voted aye. Motion carried.

This change gives the Dale County Commission the right to establish designated outdoor smoking areas to prevent smoke from entering a County building. Mr. McKinnon seconded the motion. All voted aye.
