<u>APPROVED – CHANGE ORDER – COURTHOUSE RENOVATIONS – PROBATE OFFICE</u>

Commissioner Carroll made a motion to approve the change order totaling \$21,816.00 for the Courthouse renovations. This change order is for the abatement of the old flooring, installing new flooring, replacing the paneling and installation of sheetrock and painting in the Probate Offices. Commissioner McKinnon seconded the motion. All voted aye. Motion carried.

APPROVED – ROOFING VOTING HOUSES

Commissioner Gary made a motion to approve the installation of new metal roofs on the voting facilities in Bertha, Skipperville, Sylan Grove and Midland City, at a cost of \$6,105.25. This quote was turned in by Homeworks. Commissioner Carroll seconded the motion. All voted aye. Motion carried.

<u>APPROVED – PARTICIPATION IN THE ALABAMA SPORTS FESTIVAL</u>

Commissioner McKinnon made a motion to approve Dale County's participation in the Alabama Sports Festival contingent upon County Attorney Henry Steagall's approval after researching the legalities of the Commission using taxpayer funds for this type event. Participation in the ASF will cost Dale County \$10,000 per year with a three-year commitment. Commissioner Gary seconded the motion. All voted aye. Motion carried.
