Commission Meeting Minutes – March 26, 2024

The Dale County Commission convened in a regular session Tuesday, March 26, 2024. The following members were present: Chairman Steve McKinnon; District One Commissioner Chris Carroll; District Two Commissioner Donald O. Grantham; and District Four Commissioner Frankie Wilson. Absent: District Three Commissioner Adam Enfinger.

Joe,

As we have discussed, the contractor had a major delay in getting the manholes for this project. The manufacturer was delayed 3 months trying to locate the fly ash which our specs require to be used in the concrete for the manholes. This fly ash increases the resistance to corrosion by the sulfuric acid formed from the hydrogen sulfide located in sewer systems.

As a result, I recommend that a time extension to the funding agreement be requested. I have attached the revised Attachment A to the funding agreement which includes the milestone dates for the project which have been updated.

SCOPE OF SERVICES AND SCHEDULE OF ACTIVITES

A. General Scope and Budget

The purpose of this Agreement is for The Utilities Board of the City of Ozark is to install a new 8-inch gravity sanitary sewer main starting at the proposed Career Center Building for approximately 2,700 LF and connecting to an existing 8-inch gravity sewer main. The project will also include ten sanitary sewer maintenance holes, clearing and grubbing, grassing, erosion control and asphalt removal and replacement at street crossing.

The Agreement provides for reimbursement by the County up to \$158,934.50 to cover costs associated with the project identified above. Any other expenses are to be covered by the Board.
